Pre-file searches

With the help of our pre-file search, you will obtain a quick answer if someone already has an identical or similar mark before registering your own mark. The search also includes search against Community Trademarks and, if you want, identical searches in other Community countries national registers (no figurative searches). You will get a good indication of possible obstacles before filing your own Community Trademark. We also provide our opinion on if your mark has the distinctiveness required for registration according to the Swedish Trademark Law.

Freedom to operate searches, FTO

Before you launch a new trademark on the market, it is important to assess whether you are likely to infringe somebody else's existing rights or not. A freedom-to-operate search gives a good indication of the risk of infringement.

Monitoring services

Successful companies keep a close eye on the competition. PRV InterPat offers a full range of monitoring services enabling you to keep the competitors under close watch and, more importantly, to monitor your own trademark, since the quantity of protected rights is increasing. This is of the utmost importance with regards to Community Trademarks. As you most probably know, EUIPO does not examine trademark applications against earlier rights, with the consequence that similar or identical trademarks can be registered. The holders themselves must ensure that no similar trademarks are infringing their rights. We have powerful search tools to assist you.



Search reports

Prices

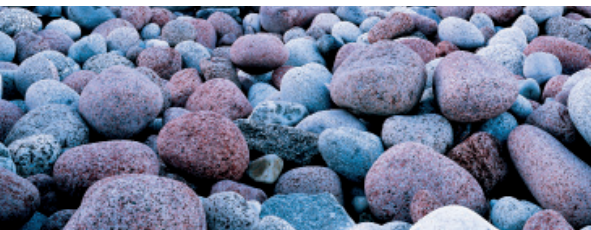
